RECENT WORK AND FUTURE PLANS

Vamos Theatre is in an exciting period of change, as an Arts Council England funded National Portfolio Organisation, and as we develop ambitious new programmes of work and extend our work into an increasing variety of contexts.

Our 2020-21 activity was hugely affected by the Covid-19 Pandemic yet it was an incredibly productive and creative year. We were dynamic in finding delivery solutions to many of our programmes and responding to the needs of communities. Digital innovation became core to our operation and necessity accelerated our earlier plans into reality. This helped to grow our audiences exponentially and extend our reach nationally and internationally.

Highlights include:

- a BBC Culture in Quarantine Commission to create How Hard is Waving?
- working closely with the health care sector to develop and tour Covid-safe production, Love Through Double Glazing.
- developing GP training responding to the challenges of Covid-19: *Communicating Through Covid Times*.
- Creating a new Walkabout Theatre act via Zoom with a leading Producer in China and local emerging artists.



Our future plans include:

- National and International Touring a new production in 2023.
- **Learning & Participation** talent development of emerging artists from a diverse range of backgrounds, a new digital learning programme, work with schools/colleges and teachers, with business leaders and more.
- **Health, Wellbeing & Social Car**e work with NHS staff, in care homes and with end-of-life settings, training and performances.
- Walkabout Theatre continuing to build our profile and develop new audiences, international artist development



TRUSTEE ROLE AND DESCRIPTION

Purpose

The purpose of a Trustee is to provide good governance and leadership to support the delivery of the organisation's objects and mission. Our Board members must act in the best interests of Vamos Theatre, sharing the responsibility with other board members for making sure that the organisation is well run. They should use any relevant knowledge or experience they have to help the Board of Trustees to reach sound decisions.

It doesn't matter if you've not been a Trustee or have experience of working with a Board before. Our current Trustees will help and guide you to provide the relevant support as you become part of the Vamos Theatre family.

Main responsibilities of Trustees

- 1. To lead the development of the organisation.
- 2. To determine and regularly review the strategic aims and plans of Vamos Theatre and to evaluate performance against agreed targets.
- 3. To ensure that Vamos Theatre acts within the law at all times and fulfils all regulatory requirements.
- 4. To ensure that Vamos Theatre has policies in place which support it to achieve its aims and that it strives to achieve best practice in all areas of its activities.
- 5. To ensure that Vamos Theatre develops strong organisational controls and manages its risks well, ensuring effective and efficient administration of the organisation.
- 6. To ensure that Vamos Theatre is well managed financially. This includes the adoption and oversight of the annual budget, the oversight of any fundraising and the proper investment of the charity's funds/management of assets.
- 7. To oversee programme planning and evaluation.
- 8. To communicate openly with all stakeholders about the work and performance of Vamos Theatre and to take into account feedback from them.
- 9. To advocate for and promote Vamos Theatre and to safeguard its reputation.

The Board has adopted the Charity Commission's Code of Governance (https://www.charitygovernancecode.org) and follows the provisions for 'smaller charities' across the areas of purpose, leadership, integrity, decision making/risk/control, Board effectiveness, diversity and accountability.

WHAT WE'RE LOOKING FOR

We are seeking a diverse range of applications with a variety of experiences: previous experience as a Trustee is not necessary. We'll work with you as you get to know us and the role and make sure you're supported.

The personal attributes we look for in a potential trustee are:

- Demonstrates a strong passion and commitment to Vamos Theatre's purpose and ethos
- Understanding and acceptance of the legal duties, responsibilities, and liabilities of Trusteeship
- Willingness to speak up, debate and discuss, providing appropriate challenge and support
- Builds positive and constructive working relationships with colleagues and stakeholders
- Strategic vision
- Ability to think creatively
- Tact and diplomacy, with the ability to listen and engage effectively
- Integrity
- A team player

Becoming a Trustee is a great way of developing yourself and get experience of managing an organisation at a strategic level plus making a valuable contribution to a charity.



TIME COMMITMENT

Length of term: 3 years in line with our Constitution

Meetings and Time Commitment:

- The Board of Trustees meets 4 times a year, plus an annual awayday and involvement in particular projects as relevant to support the work of the company.
- We like to meet in person in Worcester when we can, but are currently using Zoom for some of our meetings. Standard meetings generally last 3 hours.
- Trustees are expected to prioritise attendance at all meetings of the Board.
- Trustees are also expected to act in the best interests of the charity and to represent and promote Vamos Theatre at all times.

As is normal for Trustee roles, this role is unremunerated but reasonable out of pocket expenses (travel, and accommodation where necessary) will be reimbursed.
